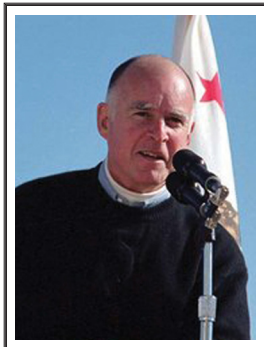




PECG'S ENDORSEMENTS for the NOVEMBER 2 ELECTION!

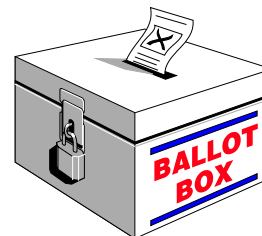

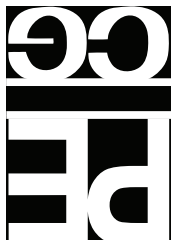
